Project Management Course - Understanding the Project Milestone

Project management milestones are checkpoints that must be defined early on in the project planning process. They help to measure progress, ensure that deadlines are met and allow for <u>take my online class for me</u> course corrections to be made along the way.

Milestones should not be confused with tasks or goals. Tasks are activities that take time and other resources, while goals determine the direction of the project.

1. Identify a Problem or Research Question

After gathering and analyzing rich qualitative data in the Empathize Milestone, it's time to clarify your research goals and identify what problem you want to solve or research question you want to explore with an interactive system. This is intended to both motivate your team and scope the next stages of work.

Using milestones proactively communicates deadlines to project stakeholders. This prevents the need for frequent check-ins. It also allows stakeholders to see how much Should We Withhold Life Support? has been made on a specific task and who's responsible for moving it forward.

Additionally, tasks can be assigned to milestones so that when a milestone is reached, all associated tasks are automatically marked complete. This helps automate project handling and makes it easy for teams to spot the critical points in a timeline, such as an important meeting or a presentation. Milestones can also be shared with anyone who doesn't have a Nifty account, allowing them to remain updated on the status of your work.

2. Create a Proposal

Once you have a solid background in your project, you can create a proposal. Your proposal is your chance to convince your readers that your project has real impact and that the method you have proposed will lead to the desired results.

To make your proposal more persuasive, be sure to include a section that describes the problem you are addressing, why it is important, and how your project will address it. This is a great place to use statistics, graphs and images.

A project proposal should be comprehensive, <u>bha fpx 4008 assessment 1 developing</u> an operating <u>budget</u> it does not need to be overly detailed. Your goal is to win your audience over, so don't spend time talking about technical details that will not be relevant to your audience. For example, you may discuss your project plan for the editing tool, but you do not need to go into detail about what specific codes will be used to implement it. To keep your audience engaged, you should also limit the length of your proposal to two pages maximum.

3. Write a Final Report

At each milestone, students are required to submit a short document and deliver a brief in-class presentation on their project's progress. These reports provide an opportunity for feedback from staff and classmates.

Write a summary of the project that identifies its goal, purpose and limitations. Include a table that documents how the work was distributed amongst team members, including names, netIDs and roles. Explain your debugging strategies and how you applied the class material to your functions.

Write a literature review that includes at least <u>BUS FPX3007 Assessment</u> pieces of credible academic literature that can be used to augment, alter or improve the course project in some way. Demonstrates a clear focus, adequate integration of additional academic resources and logical organization between topics. Shows a strong understanding of context and develops insights and assertions that could be used to change or enhance the project.

4. Present Your Proposal

Unlike goals and deadlines, which focus on looking forward, project milestones are important markers that look back. They define the major phases of a project, and they allow teams to track progress over time.

In this assignment, you will prepare a presentation and present your initial plan for the course project to your classmates and the Recitation TA. You can and will update your plan based on feedback, progress and findings. However, the purpose of this presentation is to demonstrate that you Course Project Milestone a robust initial plan that can stand on its own.

You will prepare a PowerPoint presentation consisting of 3 to 4 slides. The first slide will contain the approved patient scenario from Milestone 1 and 2 and a developed and reliable mHealth app. The following slides will describe the nurse's assessment of the patient and their learning needs, and how the mHealth app can address these needs. You will also include a list of all sources used.
